Dear Dan:

Following is a page from a web site that I believe that Lary Holland has compiled as part of his continuing battle against paying child support. The reason that this is relevant is that it appears to reflect that Mr. Holland would not pay his \$100 per week child support even if he could. In other words, it refutes any argument he may belatedly decide to make concerning his financial situation and an inability to pay. He makes it clear that despite his financial situation he is not going to pay support that "enhances the mother's life" or allows mother to "spend nights with their new boyfriends on Daddy's money." He considers his children just to be a reason for their mother to have "cash cows at father's expense." He further elaborates by describing temporary support to be "Court's way to help ensure that mother's legal fees are paid and father is in further debt." Lary's non payment of support for over 12 months is not an accident, and this should be made very clear to the Court. He has rarely paid support voluntarily in the past and it would appear that he has no intention of paying it voluntarily in the future. I suggest that we just might as well get busy suspending his driver's license and seizing his property since that is the only way we will ever collect from this fellow. If he continues in this pattern of behavior we should consider referring him to Attorney General Cox since although his arrears may not rank him with the top ten deadbeats, his attitude surely does.

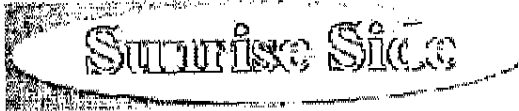


**Friend Of The Court** - Friend of the Court is an employee of the legal system not an agent trying to portray!
